

# Frequently Asked Questions

## 1. What can I do to get involved?

There are so many ways to join this effort.

- Make sure your family, friends and neighbors have signed the *Free Our Health Care Now! Petition*
- Forward weekly updates to everyone you know.
- Attend your local town hall meetings and take copies of the petition for people to sign.

## 2. I know someone who doesn't have a computer — can they still sign the petition? or Can I print out copies of the petition for my friends and neighbors to sign?

Certainly. ## 6. What will you do with all of the signatures?

On September 9, 2009, we will present your signatures to Congressional leaders and the White House

in Washington, DC in a press conference with a clear message that you don't want nationalized health care. As details are confirmed, we will keep you updated.
